

Donate-/donation contract



Purpose: Donate-/donation agreement for Looking for Global Justice

Upon receiving the donated fund from Party A, Party B shall issue (i) a financial receipt in a valid lawful form within 10 business days, and (ii) a donation certificate to Party A. Party B shall register the donated assets after which are received from Party A.



Article 3 Party A indicates that the donated money should be used for the following purposes

Name the project you support

Party B is entitled to put the donated funds to good use according to the purposes set out in this agreement. Party B may not change the stated uses of the donations.

If a change of purposes is required, Party B must obtain the consent of Party A and both parties will come to an agreement on this change.

Article 4 As a donor/gifter, Party A shall not declare any rights or proposals such as economic benefits and intellectual property rights in relation to the donation/gift.

Article 5 The donation/gift will be adjusted accordingly under the following conditions:

- (i) Party B has the right to use Party A's charitable purpose and original intent of the funds in a similar fund during the operation of the fund.
- (ii) If the realization of the intended project cannot be realized for any reason, the funds raised for the project will be transferred to another similar project.
- (iii) If another similar project is undertaken, Party B is not materially in breach of the Foundation Regulations.

Article 6 All notices and requests under this Agreement must be in writing and may be delivered by letter, email or in person. Either party may change its contact details by notifying the other party in writing within 5 business days. Both parties confirm that their contact details are as follows:

Article 7 Each party is entitled to suspend the performance of its obligations under this Agreement for any period during which a Force Majeure Event prevents the party from performing all or any part of the obligations. If a force majeure event occurs, both parties will promptly decide in friendly negotiations how to perform the contract. As soon as the force majeure events and their influence have disappeared or been



eliminated, both parties shall immediately resume the performance of all their obligations under this contract. If the force majeure events and their influence cannot disappear or be eliminated, resulting in one of the parties being unable to continue their performance of the contract, both parties may terminate the contract through negotiations, and the party suffering from the force majeure will not held liable.

Article 8 All disputes arising from the execution of the contract will be settled through mutual negotiations of both parties or through the mediation of the competent authorities. If negotiation and mediation fail to resolve the dispute, either party may submit the case to the District Court,

Article 9 This Agreement comes into effect on the date of signature by both parties. The donation/gifts, which is a charitable activity, cannot be cancelled or terminated unless the statutory circumstances or the agreed circumstances under this agreement occur.
